D.1 Procedure

Responsible	Procedure Steps		W/I	
Student	1	Adherence to attendance requirements		
	1.1	Make sure you understand the attendance requirements as outlined in the policy.		
	2	Absences from class		
Student	2.1	Medical and approved absences		
	2.1.1	If absent from class due to illness or any other medical condition submit the original copy of your Medical Certificate/s to the Student and Academic Services (SAS) Unit.		
	2.1.2	Where it is known in advance that you will not be attending classes, approval in advance is required from the Academic Directorate.		
	2.1.2.1	Make an appointment to see a member of the Academic Directorate to gain approval.		
Director of Studies	2.1.2.2	Notify SAS and teacher to confirm that the student's absence has been approved.		✓
Student Services	2.2	Enter medical or approved reason(s) against student absences in Navigate.		✓
Teacher	3	Recording attendance		
	3.1	Record attendance through the portal daily.		✓
	3.1.1	Notify Accommodation and Academic Directorate of daily absences for students under 18.		
SAS Accommodation	3.2	Follow up with under 18 students who are absent.		
Academic Support	3.3	Generate attendance reminder email in Week 1.		✓
Academic Support	4	Students absent for three or more (consecutive) days		
	4.1	Follow up on student welfare.		

Responsible	Procedure Steps		W/I
Academic Support	4.2	Where a student has been absent for five consecutive days, refer the student to the Director of Studies.	
Director of Studies	4,3	Monitor the student and provide academic support; refer to class teacher for potential extensions for assignments or work missed in compassionate and compelling circumstances.	
Academic Support	5	Generation of attendance percentage reports and letters	
	5.1	On a weekly basis within the study period as defined in the policy generate Navigate report to identify the individual student attendance percentage.	✓
Academic Support	6	Intention to Report and appeals	
	6.1	Send an email notification to each student to notify an Intention to Report has been issued including final date of appeal submission.	✓
Student	6.2	You may register an appeal within 20 working days of the date on the Intention to Report letter if you wish.	
Student	6.3	If you have chosen to lodge an appeal you must continue to attend class during the appeal process.	
Academic Support	7	Apply Immigration condition	✓
	7.1	If the student does not register an appeal within 20 working days then report them through PRISMS.	✓
	8	Provide reports to key staff	✓
Academic Support	8.1	Send reports to Academic Directorate, Accommodation and any other staff as required.
