### D.1 Procedure

Responsible	Procedure Steps		W/I
	<b>1</b>	<b>Understanding the requirements</b>	
<b>Student</b>	<b>1.1</b>	Ensure you have read and understood the FSP Academic Standing Policy.	
	<b>2</b>	<b>Identifying students at risk</b>	
<b>Program Coordinator (FSP)</b>	<b>2.1</b>	Perform orientation diagnostic testing in literacy and numeracy.	
	<b>2.2</b>	Advise students identified with low scores to seek support from the Student Learning Advisor (SLA).	
<b>Student Learning Advisor (SLA)</b>	<b>2.3</b>	Around week 5 ask teaching staff to complete Students at Risk form (generally at the time of the first assessment).	
<b>Teachers</b>	<b>2.4</b>	Complete Student at Risk forms and return to the SLA.	
<b>SLA</b>	<b>2.5</b>	Maintain ongoing formal and informal communication with teaching staff to identify students at risk.	
	<b>3</b>	<b>Term report</b>	
<b>Academic Support</b>	<b>3.1</b>	Run the Risk Report and send to the Program Coordinator (FSP) and SLA for review and confirmation.	
<b>Program Coordinator (FSP) or SLA</b>	<b>3.2</b>	Check the Term Report, highlight any students at risk and return to Academic Support.	
<b>Academic Support</b>	<b>3.3</b>	Enter risk conditions as advised and commence the at risk process.	
	<b>4</b>	<b>Intervention strategy</b>	
<b>Program Coordinator (FSP) or SLA</b>	<b>4.1</b>	Advise students identified as at risk to make an appointment.	
<b>Student</b>	<b>4.2</b>	Make an appointment with the SLA.	
<b>SLA</b>	<b>4.3</b>	Issue a Student Performance Contract (SPC) to the student if required;	

Responsible	Procedure Steps		W/I
		Implement a Personal Study Plan (PSP) and counsel the student in regards to time management and study skills; and  Organise individual meetings for the students to meet with their module teacher(s).	
Student	4.4	Continue to study with the SPC in place.	
	4.5	Attend interviews as required with the SLA consistent with the SPC and meet with module teacher(s) as required	
SLA	4.6	Monitor student's progress against their SPC.	
	4.7	Advise the student that unsuccessful completion of the SPC may result in them being reported to Immigration.	
	<b>5</b>	<b>Appeals</b>	
Student	5.1	If you want to lodge an appeal refer to the <b>Student Grievances and Appeals Policy and Procedure.</b>
